




Edison Dear Private Landowner,

## FREQUENTLY ASKED QUESTIONS

#### Q. Why is SCE surrendering their license?


A. In 2006, the Army Corps of Engineers (Corps) began a dam safety modification study and determined the dam didn't meet earthquake safety standards. As a result, the Corps began a dam safety modification project. In 2017, they began seismic safety modifications to the Auxiliary Dam which resulted in the condemnation of SCE's canal conduit through the dam. The conduit was abandoned in place by filling it with concrete and rendering the Project nonfunctional. Because of that, SCE is preparing to file a license Surrender Application with the Federal Energy Regulatory Commission (FERC).


#### Q. How long does the Surrender Application process take?


- A. SCE will submit the Draft Surrender Application to FERC in January 2023. It can take 2 to 5 years for FERC to review and give SCE approval to begin the decommissioning process.
- Q. What does SCE do while they are waiting for the FERC approval of the Surrender Application?
- A. SCE will continue to maintain the Borel Canal and associated facilities as they are now until such time as decommissioning activities, such as permitting, start.
- Q. When will construction begin?
- A. Based on the current schedule, SCE anticipates that construction along the canal could begin in 2027, or later.
- Q. Can the public participate in this process?
- A. Yes! The Draft Surrender Application will be available for public review during a 45-day review period starting on December 14, 2022, through February 2, 2023. Access the document: www.borelhydro.com.






